Conditions for Hong Kong to Cape Town Aboard Queen Victoria Cruise

Deposits and Payments - A non-refundable deposit of \$1,250 per person is payable within 3 days of booking. This deposit is not refundable should you later cancel. The balance is payable 1st December 2021. Macleay Valley Travel often has to adhere to strict payment deadlines and your booking on the tour may be cancelled if final payment is not received by the due date, with no refund applicable. The deposit amount listed above is based on a lead-in inside cabin. Higher deposits apply for higher cabin categories.

Refunds and Cancellations - Cancellations after final payment will result in a refund limited to whatever we can recoup from the cruise company. Changes and cancellations of bookings will likely incur fees from suppliers. Any refund for a cancelled booking will not be paid until the supplier provides the refund to the agent.

Airline Tickets – Flights are not included in the price, however we can arrange them for you upon request. Please note that any changes made to airline tickets once they have been issued will likely incur high cancellation and/or reissue fees. These fees are typically set by the airline and are outside of our control.

Insurance - Adequate travel insurance is essential. We can arrange this for you if desired. Macleay Valley Travel offers Suresave Travel Insurance. Please note that we can only process your travel insurance when we have received full payment for the insurance and the signed Suresave Travel Insurance application form. Until this time the travel insurance cannot be processed and will not be valid. Macleay Valley Travel will bare no responsibility for any consequences that may occur as a result of an incomplete insurance application.

Passports - All travellers require a current passport with at least 6 months left on it upon your return to Australia. Non-Australian passport holders require a re-entry visa for Australia. An ETA is required for Sri Lanka. Current cost is USD \$35.

Basic Tour Price and Taxes – Port charges & taxes are included in the basic tour price if the tour is paid in full on or before the due date on the final invoice. Macleay Valley Travel reserves the right to charge for any increase in taxes and fuel levies if the tour is not paid in full by the due date.

Not Included in the Cost - All items of a personal nature such as telephone calls, drinks, excess baggage, tips, meals, (except those specified in the itinerary), travel insurance and transfers. Similarly, credit card payments (Visa/MasterCard) can only be accepted if 1% is added to the price to help defray the heavy merchant fees charged to us by the credit card companies. There is a 1.8% surcharge for American Express.
