- 18.06.20** **Australia – Denpasar, Indonesia**
Depart Brisbane at 10.10am on VA 43, arriving in Denpasar at 2.45pm.
Depart Sydney at 4.30pm on QF 43, arriving in Denpasar at 9.05pm.
Depart Melbourne at 4.50pm on QF 45, arriving in Denpasar at 9.10pm.
Upon arrival you will have a private transfer to your hotel, the Ibis styles Bali Legian in a Pool View Room including breakfast, for a two night stay.
- 19.06.20** Today is at leisure in Denpasar.
- 20.06.20** Today you are transferred to the Benoa Harbour to board the Star Clipper. Ship departs at 7pm.
Life onboard the Star Clipper is not a cruise ship in the ordinary sense. You will find there are no rigid schedules. You are free to do as you wish with your days and evenings. To entertain you at certain ports, the ship brings local performers on board to give passengers an authentic taste of the local music and arts. - 24.06.20** Arrive Satonda Island at 12pm, departing at 5pm.
- 25.06.20** Arrive Gili Meno/Gili Trawangan at 11.30am, departing at 5.30pm.
- 26.06.20** Arrive Gili Nanggu at 10am, departing at 5.30pm.
- 27.06.20** Arrive Benoa at 6am and disembark the ship. Make your own way to the Ibis Styles Bali Benoa for an overnight stay including breakfast. Your room has been booked from the previous night so you can get straight into your room upon arrival.
- 28.06.20** This morning is at leisure to explore the area. Your hotel room has been booked so you can stay in it right up until your included transfer to the airport for your flight home.

Deposits and Payments - A non-refundable deposit of \$2,250 per person is payable within 3 days of booking. This deposit is not refundable should you later cancel. The balance is payable in full 3 months prior to departure.

Refunds and Cancellations - Cancellations after final payment will result in a refund limited to whatever we can recoup from the airline.

Passports - All travellers require a current passport with at least 6 months left on it at the end of the tour. Non-Australian passport holders require a re-entry visa for Australia. No visas are required for this package if travelling on an Australian passport.

Basic Tour Price and Taxes - Air taxes and fuel levies are included in the basic tour price if the tour is paid in full on or before the due date on the final invoice. Macleay Valley Travel reserves the right to charge for any increase in air taxes and fuel levies if the tour is not paid in full by the due date.

There is a 2.75% surcharge for American Express.
