- 06.03.18** Depart Sydney at 11.15am on flight QF 81, arriving in Singapore at 4.30pm. Depart Brisbane at 11.50am on flight QF 51, arriving in Singapore at 5.55pm. Depart Melbourne at 12.20pm on flight QF 35, arriving in Singapore at 5.25pm. You are transferred to the Hotel Jen Tanglin by Shangri-La in Singapore for an overnight stay with breakfast.
- 07.03.18** Today you are transferred from the hotel to the cruise terminal to board the Sapphire Princess. The ship departs Singapore at 4pm.
- 08.03.18** At sea.
- 09.03.18** Arrive Koh Samui, Thailand at 8am, departing at 5pm.
- 10.03.18** Arrive Bangkok (Laem Chabang) Thailand at 7am, departing at 7pm.
- 11.03.18** At sea.
- 12.03.18** Arrive Ho Chi Minh City (Phu My) Vietnam at 7am, departing at 6pm. Please note A visa is required for Vietnam, which can be obtained onboard the ship at a current cost of USD \$56 per person. A passport sized photograph is required for this application.
- 13.03.18** At sea.
- 14.03.18** Arrive Singapore at 7am. After disembarking the cruise ship you are transferred to the Hotel Jen Tanglin by Shangri-La for a two night stay with breakfast.
- 15.03.18** Today is at leisure in Singapore. During your stay you will have the use of a Singapore Hop-On Hop-Off City Sightseeing Pass, as well as a 3½ hour guided city tour visiting Merlion Park, Thian Hock Keng Temple, handicraft centre, National Orchid Garden and Little India.
- 16.03.18** Today you are transferred to the airport for your flights home. Sydney passengers depart Singapore at 7.15pm on QF 82, arriving in Sydney at 6.10am the next morning (17.03.18). Melbourne passengers depart Singapore at 7.45pm on QF 36, arriving in Melbourne at 6.15am the next morning (17.03.18). Brisbane passengers depart Singapore at 8.50pm on QF 52, arriving in Brisbane at 6.45am the next morning (17.03.18).

Conditions for Sapphire Princess Thailand & Vietnam Fly, Cruise & Stay

Deposits and Payments - A non-refundable deposit of \$1,400 per person is payable within 3 days of booking. This deposit is not refundable should you later cancel. The balance is payable in full 12 weeks prior to departure.

Refunds and Cancellations - Cancellations after final payment will result in a refund limited to whatever we can recoup from the airline.

Airline Tickets - Please note that any changes made to airline tickets once they have been issued will likely incur high cancellation and/or reissue fees. These fees are typically set by the airline and are outside of our control

Insurance - Adequate travel insurance is essential. We can arrange this for you if desired.

Passports - All travellers require a current passport with at least 6 months left on it at the end of the tour. Non-Australian passport holders require a re-entry visa for Australia. A visa is required to enter Vietnam and is arranged while on board the cruise ship, approximate cost \$56 USD per person. Please note that this price is subject to change.

Basic Tour Price and Taxes - Air taxes and fuel levies are included in the basic tour price if the tour is paid in full on or before the due date on the final invoice. Macleay Valley Travel reserves the right to charge for any increase in air taxes and fuel levies if the tour is not paid in full by the due date.

Not Included in the Cost - All items of a personal nature such as telephone calls, drinks, excess baggage, tips, meals, (except those specified in the itinerary), travel insurance etc. and airport transfers. Similarly, credit card payments can only be accepted if 2% is added to the price to help defray the heavy merchant fees charged to us by the credit card companies. There is a 3% surcharge for Diners Club.
