- 23.03.19** Disembark the ship at 7am this morning. You are then transferred to the Novotel Nathan Road or similar for a two night stay with breakfast.
- 24.03.19** Today there is an included half day Hong Kong Island tour, including a Tram Ride to Victoria Peak, visits to Aberdeen and Stanley Market. Plus a complimentary Rickshaw open top bus ticket on either one of the two routes, Hong Kong Island or Kowloon.
- 25.03.19** Today is at leisure. This evening you are transferred to Hong Kong airport for your flight home.
Brisbane passengers depart Hong Kong at 8.00pm on QF 98, arriving in Brisbane at 6.45am the next morning (26.03.19).
Melbourne passengers depart Hong Kong at 8.10pm on QF 30, arriving in Melbourne at 8.40am the next morning (26.03.19).
Sydney passengers depart Hong Kong at 8.15pm on QF 128, arriving in Sydney at 8.10am the next morning (26.03.19).

Conditions for Sydney to Hong Kong aboard the Sun Princess - Fly, Cruise & Stay

Deposits and Payments - A non-refundable deposit of \$2,200 per person is payable within 3 days of booking. This deposit is not refundable should you later cancel. The balance is payable in full 12 weeks prior to departure.

Refunds and Cancellations - Cancellations after final payment will result in a refund limited to whatever we can recoup from the airline.

Airline Tickets - Please note that any changes made to airline tickets once they have been issued will likely incur high cancellation and/or reissue fees. These fees are typically set by the airline and are outside of our control.

Insurance - Adequate travel insurance is essential. We can arrange this for you if desired.

Passports - All travellers require a current passport with at least 6 months left on it at the end of the tour. Non-Australian passport holders require a re-entry visa for Australia. A visa is required to enter Vietnam and is arranged while on board the cruise ship, approximate cost \$56 USD per person. Please note that this price is subject to change.

Basic Tour Price and Taxes - Air taxes and fuel levies are included in the basic tour price if the tour is paid in full on or before the due date on the final invoice. Macleay Valley Travel reserves the right to charge for any increase in air taxes and fuel levies if the tour is not paid in full by the due date.

Not Included in the Cost - All items of a personal nature such as telephone calls, drinks, excess baggage, tips, meals, (except those specified in the itinerary), travel insurance etc. and airport transfers. Similarly, credit card payments (Visa/MasterCard) can only be accepted if 1% is added to the price to help defray the heavy merchant fees charged to us by the credit card companies. There is a 2% surcharge for American Express Club.

Health and Fitness - Macleay Valley Travel recommends that the passenger is reasonably healthy and/or fit to participate in this tour. Persons with a disability requiring special assistance must be accompanied by a companion. Macleay Valley Travel and their representatives cannot provide this service. Macleay Valley Travel reserves the right to accept/decline or terminate a passenger's participation in the tour under certain circumstances.

Booking through other Agents - As we keep the cost of our tours as low as possible, there is insufficient margin for us to be able to pay commission to other travel agents, so some bookings can only be accepted if the client pays the other agent's commission.

As such, you are assured of a consumer focused and quality assured business, ensuring professional conduct and ethical business practices.
